

APA DIVISIONS COUNCIL FY 2018 ANNUAL DIVISION PERFORMANCE REPORT NOVEMBER 15, 2018

Division: Regional and Intergovernmental Planning Division (RIPD) Chair (or primary author if not Chair): Mark VanderSchaaf (Chair)

1. Workplans and Budgets

Our Workplans and Budgets for FY2018 and FY2019 reflect activities undertaken by new Executive Committee (which took office in January 2017) to solidify and advance previous accomplishments of RIPD. See attachments (Appendices a. and b.). In FY2018, RIPD administered a conservative budget with actual expenses well under proposed expenses. For FY2019 RIPD will continue advancing policy emphases established in FY2018, while exploring new emphases and strengthening its communications efforts, particularly for new members.

2. Communications

RIPD's Executive Committee appointed Becky Bradley to be the Division's Communications Officer in 2017. Under her leadership, the Executive Committee approved an initial Communications Strategy, most recently updated on January 23, 2017, which outlined four goals and appropriate actions to achieve them: (1) Promote the work of the Division and regional and intergovernmental planning; (2) Engage Division membership, planning community and public generally about regional and intergovernmental planning; (3) Support the work of the Division and Division membership through regular and reliable communications; and (4) Assist with membership growth by communicating the value of the Division.

FY2018 Actions in support of this strategy include:

- a. Newsletter (See Appendix c): During FY2018, RIPD used APA's MailChimp intensively to publish eleven e-newsletters which combined news with articles exploring issues in greater depth. Publication dates were November 6, 2017; January 1, 2018; February 16, 2018; March 1, 2018; March 16, 2018; April 4, 2018; April 11, 2018; April 17, 2018; April 26, 2018; May 5, 2018; and September 6, 2018.
- b. Website updates: RIPD collaborated with APA to prepare for a changeover to a new system for updating website material. That process took longer than expected so no

changeover of our website was possible in FY2018. Instead, we focused on updating our opening statement and photograph, and adding content to our website. Most notably, we documented the work of our annual Regional Livable Communities Forum from its inception in 2014 through 2018.

c. e-blasts:

In addition to our e-newsletter, RIPD released an e-blast during FY2018 to welcome new student members shortly after APA's shift to free student memberships began to result in substantial growth in division membership numbers. The email we crafted for this e-blast was identified as a "best practice" in the Student Membership white paper released by the Divisions Council and featured at the luncheon during the Fall Divisions Council meetings in Washington, DC (See Appendix d. below).

d. Social media sites:

RIPD owns and maintains a LinkedIn site with 118 current members.

e. Membership surveys:

RIPD conducted two formal surveys during FY2018.

As part of our "Regional Planning for Integrated Water Management" program, we conducted a survey in May-June of members and other key contacts to determine policy issues and promising practices relating to this emerging trend. A total of 45 responses were received with relatively even participation in most regions across the U.S., with the exception of the Mountain West and Great Plains regions which saw a lower response rate. There was a good distribution of responses across disciplines, with the greatest number of responses representing either local or regional planning agencies, or other types of planning work. Over 60 percent were aware that their state had a water resources management plan with evidence of integrated water planning at the state level covering some issues, particularly water supply and stormwater. At the regional level, approximately 46 percent of respondents had a regional water resources management plan, with similar results in terms of integration across water issues. The survey showed a high degree of stakeholder involvement in planning for water at both the state and regional levels. [Appendix e.]

We also conducted a general membership survey in September 2018 to help guide the work of the new 2019-2020 Executive Committee. Survey questions were designed to elicit responses from new student members about their needs, to obtain input on continuation of the Livable Communities Forum, and other proposed RIPD activities. However, we received a very low response rate of 16 responses. As a result, the survey was re-issued in November. [Appendix f.]

- f. Specific outreach for volunteer opportunities: In FY2018 RIPD engaged with students interested in serving as a representative to our Executive Committee, and with regular members interested in helping with a FY2019 Membership Program.
- g. Other: The RIPD Division was featured prominently in "Connecting to Regional Planning," an article published in the February 2018 issue of *Planning* magazine. The RIPD Division prepared a hard-copy brochure to be used at NPC18 to publicize RIPD conference sessions, our annual meeting, and our reception.

3. Annual National Planning Conference Activities

a. General sessions, facilitated discussion, mobile workshops, or other:

Members of the Division's Executive Committee conducted three events at NPC18.

- 1. Sharon Rooney gave a "lightning talk" PowerPoint presentation in the APA Pavilion on the RIPD's 2018 Divisions Council Product Grant to develop a policy handbook on regional water planning for climate resilience. She provided an overview of the project's goals and objectives and existing APA policies on water and climate, introduced the One Water perspective, described the project team, including student participants and regions to be examined. She outlined a project schedule to complete the handbook by the end of the calendar year and invited the audience to participate in a survey being conducted as part of the project.
- 2. Mariia Zimmerman moderated a session on "Implementing Sustainability Plans and Livable Community Programs" (NPC 188191) featuring speakers from the Metropolitan Transportation Commission (Ken Kirkey), the Mid-America Regional Council (Beth Dawson), and the North Central Texas Council of Governments (Shawn Conrad). The session was well attended and dove into the details of how three regions with very different political and institutional structures are addressing regional planning needs that cross transportation, housing, economic development and social equity issues. Each of the presenters provided specifics on their programs, performance measures, and organizational structures designed to bridge suburban, urban and rural local community issues across a regional scale.
- 3. Mark VanderSchaaf moderated a session on "Regional Planning for Arts and Culture" (NPC188192) featuring speakers from Boston's Metropolitan Area Planning Council (Jenn Erickson), the Chicago Metropolitan Agency for Planning (Stephen Ostrander), and the Puget Sound Regional Council (Ben Bakkenta). This session was the first-ever NPC presentation highlighting a this new "emerging trend." The session was well-attended, and received an overall rating of 4.29 on a 5.00 scale with session participants endorsing this trend as an emphasis of the Division.

- b. Annual Business Meeting:

RIPD's Annual Business Meeting was held on Sunday, April 22, 4-5:30 pm at the Riverside-Royal Room of the Hilton Hotel in New Orleans, during NPC18. See attached Business Meeting notes, which includes attendance list (Appendix g.).

c. Staffing of the Divisions Council booth at the direction of the Divisions Council:

RIPD Chair Mark VanderSchaaf staffed the Divisions Council booth from 9am – 10am on Sunday, April 22.

4. All Other Events/Programs

a. Education programs (including webinars, events at local APA conferences, events cosponsored with other organizations, etc.):

The Division again sponsored a Regional Livable Communities Forum to bring together planners working in MPOs and regional planning agencies to share emerging best practices for how their agencies are supporting innovative local implementation strategies that align with regional plans and goals. The day-long Forum was attended by 54 participants representing a range of regional agencies from metropolitan planning agencies to regional councils of governments, local governments and consultants from large and medium size metropolitan areas. Panels explored a range of topics important to regional planners, including such issues as planning for resiliency which focused on efforts in New Orleans, Houston-Galveston, and South Florida; strategies to coordinate land use and transportation with a focus on Seattle, Gary-Indiana and the Boston regions; emerging federal policies and new guidance from USDOT, HUD and Treasury; breaking down silos to address critical and interrelated emerging trends in the regional planning process; and regional approaches to emerging housing needs and challenges which focused on efforts in Minneapolis-St Paul, Portland, Oregon, Salt Lake City, Los Angeles, and Atlanta. Over a working lunch, participants discussed the different ways their regions and agencies are tackling the challenge of long-range planning and capital budgeting in a time of fiscal uncertainty.

b. Networking/social events (events at local APA conferences, events co-sponsored with other organizations, etc.)

RIPD held a joint reception with the County Planning Division during NPC18. It was held on Sunday, April 22, from 6-8 pm, at Flamingo A-Go-Go, 869 Magazine Street, New Orleans.

c. Recognition events/programs:

At our annual meeting, Mariia Zimmerman (Vice Chair for Metropolitan and Regional Policy) was honored for her work in organizing the Regional Livable Communities Forum in past years.

d. Awards you give out (student papers, scholarships, diversity, etc.):

No awards given in FY2018, but student contributions were sought and honored for their role in advancing the "Regional Planning for Integrated Water Management" program and the policy guide under preparation.

e. Any Division management meetings/conference calls:

The RIPD Executive Committee held regular monthly, one-hour conference call meetings to coordinate its work program progress. In addition, conference call meetings were held with program committees as needed to prepare for the annual Livable Communities Forum, to begin launching new programs focusing on regional strategies for climate change mitigation and adaption, and regional strategies to elevate arts and culture. Also, conference call meetings of the Communications Committee were conducted.

f. Other events:

5. Membership

RIPD's membership in FY2017 was 618, growing to 1,252 in FY2018, an increase of 103 percent. For the total of all divisions, the percentage growth rate during the past fiscal year was 99 percent, so RIPD exceeded the Divisions Council average. As was the case with all divisions, RIPD's explosive growth was especially fueled by a large increase in student members.

During FY2018, our membership participated in three RIPD committees: a Regional Livable Communities Committee (convened by Mariia Zimmerman and Amy Cotter), a Regional Planning for Integrated Water Management Committee (convened by Sharon Rooney), and a Communications Committee (convened by Becky Bradley).

6. Division Assistance Programs

As part of the process of preparing this report, RIPD members were surveyed in an e-newsletter on October 31, 2018, regarding their involvement in Division assistance. The following are responses received.

Assistance in response to external requests: Layton Olson, Facilitator of the Internet Public Trust, provided resources in support of consensus building for "Smart and Connected Communities in the Digital Age" to a variety of organizations including civic advocacy and resource development networks in Illinois, Michigan, Alabama, California and New Jersey
- c. Members quoted or cited in a publication: Gary Becker, the Executive Director of the Local Government Institute of Wisconsin, published an article entitled "Local Governments Collaborating Imagine That," in the October 2018 issue of *The Municipality*; Joe Feinberg, AICP, published several letters to the editor of the Washington Post regarding overdevelopment and the extent to which it contributes to further congestion, air pollution, and related environmental problems

7. Research and Publications

To continue the mission of the Regional and Intergovernmental Planning Division (RIPD) to provide Division members and APA at large with best practices in regional and intergovernmental planning, the RIPD Executive Committee launched a project in 2018 to more thoroughly examine emerging trends in regional climate change mitigation and adaptation planning highlighted in the PAS report. The Division's research focuses on water-related issues that are being impacted by climate change identified in APA's 2016 Water Policy Guide focused on five distinct regions in the U.S.

To assist with our effort to conduct this research, we engaged with students and faculty at the University of Minnesota Humphrey School of Public Affairs and at the University of Washington, and applied successfully for a Divisions Council product grant to produce a Handbook for Division members. Our goal is to complete the Handbook by December 31, 2018.

The Division is actively supporting APA's Infrastructure Task Force, created by President Bowen in December 2017. RIPD members Dan Reuter and Rich Hall belong to the Task Force, while Mariia Zimmerman is acting as its Chair.

8. Elections

Our Division held elections for 2019-2020 offices in October of 2018. The Nominating Committee for candidates consisted of Lee Schoenecker (chair,), Dan Reuter (chair), Robert Leiter, and Lee Schoenecker.

The officers of the Division previously selected Becky Bradley to be the Division's Communications Officer and in 2018 selected Kyle Smith to be the Student Representative to the Executive Committee for that year. Immediate Past Chair Mark VanderSchaaf will continue to serve on the Executive Committee.

9. Financial Report

As requested, we are providing the Financial Report for FY2018 in Appendix h. below. As is evident from this report, we are ending FY2018 with a substantial balance of \$7,159.08, an amount higher than the FY2017 ending balance of \$5,730.30. We were intentionally frugal in FY2018 to ensure that we would have resources to support an important new program (the emerging trends in regional climate change mitigation and adaptation planning project discussed in Item #7 above), and to continue supporting the annual Livable Communities Forum discussed in Item #4.a. above.

10. Bylaws

RIPD adopted a major overhaul of its bylaws in FY2017, following APA's latest Model Divisions Bylaws (See Appendix i. below). The draft bylaws were prepared by the RIPD Executive Committee under the leadership of the Chair, reviewed by RIPD membership, and adopted at RIPD's annual meeting. No changes were made in these new bylaws in FY2018.

11. Divisions Council Meetings

As chair, Mark VanderSchaaf attended and represented the Division at all three Divisions Council meetings: February (virtual), April and September.

12. APA Development Plan

In FY2018 RIPD focused on three initiatives consistent with APA's Development Plan strategies of being relevant, nimble, and out in front of issues and trends; and, to advance sustainable planning and other best practices. The first initiative was to develop a policy handbook for Division members and other related professions on promising regional approaches to integrated water management to address climate change. Second, RIPD continued to provide leadership and support for the fifth consecutive year to conduct an annual regional livable communities' forum just prior to the APA national conference. This day-long event, also sponsored in 2018 by the

Lincoln Institute of Land Policy and led by Division Executive Committee members Mariia Zimmerman, Amy Cotter, and former RIPD Chair Lee Schoenecker, provided an opportunity for regional planners across the country to share best practices in regional land use and transportation plans and strategies, as well as other issues involving multi-partner collaborations to implement regional plans. RIPD will continue to provide financial support and leadership to help the program evolve in FY2019 to encompass new and emerging issues and trends. Third, RIPD continued to provide high-quality educational products and conferences by identifying a new emerging trend – regional planning for arts and culture – as an ongoing program that we will support in the coming years. Through the efforts of Mark VanderSchaaf, outgoing RIPD Chair, RIPD conducted a well-attended and well-received presentation on the subject at NPC18 in New Orleans. Mark has developed a proposed workplan and budget for FY2019 that will provide scholarships for student assistance to support development of a survey instrument and other educational materials. Finally, RIPD continues to strive to be responsive to our members by developing a sound program for growth and retention strategies for our membership, particularly the large number of student members that have joined the Division this year.

13. Division Challenges

Three challenges are especially notable as we transition from FY2018 to FY2019:

- 1. Communications: Our biggest Communications challenge regards populating our website, and taking better advantage of other social media tools. We were expecting an imminent change in technology allowing us to make our own revisions to the website but eventually learned that those changes are rolling out very slowly consequently we plan to keep updating our website the old-fashioned way by reporting needed changes to our APA liaison.
- 2. Membership: We are heartened by the explosive growth in student members, and also by a significant increase in our non-student membership in FY2018. Now the challenge for us is to implement programs that will enable us to serve our growing membership base well. To that end, we have enlisted two talented RIPD members to help with this process: Bridget Callea and Troy Hayes. Bridget is a planner at WGI, where she works predominantly in the public realm in the state of Florida and other southeastern states. She recently completed her Masters (May 2018) in the Department of Urban and Regional Planning at Florida State University and joined RIPD as a student member when the email invitation came out from APA last year. Troy is a planner with extensive experience in the public, private and research sectors. He is the Founder and Managing Director of Troy Planning + Design a planning, urban design and architectural consultancy based in Portland Oregon with three offices in the United Kingdom (London, Manchester and Hampshire). He is a member of the American Institute of Certified Planners (AICP) and a chartered member of the Royal Town Planning Institute (MRTPI). Together, they will be focusing especially on the use of social media to enhance communications with new members, with a goal of retaining new non-student members, and transitioning student members into regular non-student members.
- 3. New Executive Committee: This is a happy challenge to have, as we are quite excited about the new team that will comprise the Executive Committee. Our challenges with the new committee will be team-building, and also logistics. Of note, each of the new Executive Committee members has been involved in past years designing and attending the Division's

Livable Communities Forum which also suggests that event is useful to growing our leadership pipeline and involving members within Division work. Our current Executive Committee is comprised primarily of East Coast planners, which facilitated coordination but also didn't take full advantage of perspectives from the rest of the country. Our new Executive Committee includes members from Massachusetts, New York, Pennsylvania, Washington DC, Minneapolis-Saint Paul, Denver, and San Francisco, providing a rich geographical diversity. With our new First Vice Chair (Ken Kirkey) hailing from San Francisco, the site of NPC19, we especially want to take full advantage of the opportunities for our division that his leadership will present.

14. Shout it from the Mountains

Six Highlights for RIPD's FY2018:

- 1. Robust growth: As documented above, our division grew substantially in FY2018, both in student memberships and in regular paying memberships. Our combined membership percentage growth of 103 percent surpassed the Divisions Council total growth of 99 percent.
- 2. Reputation as a generator of "best practices" in student engagement. Chair Mark VanderSchaaf contributed to the Divisions Council white paper on student engagement, which highlighted our division's student welcome letter and student engagement work program as best practices. As described in Item #13 above, we now have a strong pair of division members preparing to advance a strong program to retain new members and transition student members into regular members.
- 3. Evolution of the Regional Livable Communities Forum. After five years, this one-day event has become institutionalized as an annual attraction for leaders in the field of regional planning. In its early years, the forum focused especially on integrating transportation and land use issues. In 2018, it began to expand to consider how collaborative partnerships are working to implement programs addressing a broader range of regional issues. Attendance has steadily grown and each year the Forum receives strong evaluation responses that also help to inform future programs.
- 4. Development of the "Regional Strategies for Climate Change Mitigation and Adaptation" program, which was launched in FY2017 under the direction of RIPD First Vice-Chair Sharon Rooney. In FY2018 his program gained a partner in the form of the University of Minnesota's Humphrey School of Public Policy that offered a graduate student capstone course focusing on integrated regional water management strategies. The program also benefited from the work of another student member who prepared a case study of integrated water management in Texas. The program received an APA product development grant and its work contributed both to NPC18 (talk at the APA booth) and to APA's Water and Planning Connect conference.
- 5. Launch of a "Regional Planning for Arts and Culture" program. This program is under the direction of RIPD's chair, Mark VanderSchaaf, the retired regional planning director of the Minneapolis-Saint Paul Area Metropolitan Council, a founding member of APA's Arts in

Planning Interest Group, and now a part-time placemaking consultant for Forecast Public Art. The initial activity of this program was an NPC18 session as described in Item #3 above. It is slated for further development in FY2019 via a project to document regional planning agencies with arts and culture programs, and to identify multi-jurisdictional efforts to create public art in transit and bicycle/pedestrian corridors.

6. Ongoing efforts to identify, analyze and help guide a variety of "emerging trends in regional planning." The policy-related programs described above are all an outgrowth of a determination on the part of our Executive Committee to continually grow the work represented in the 2017 *Emerging Trends in Regional Planning* PAS report. At our 2018 annual meeting, guidelines were adopted to shape how additional programs will be created in the future (see attached Appendix j).

Planners should consider climate change

At the time of this E-News, two of our nation's largest metropolitan areas have been devastated by the effects of Hurricanes Harvey and Irma. The frequency and intensity of these natural disasters are expected to continue and intensify because of climate change.

In the Division's recent PAS report, Emerging Trends in Regional Planning, we noted that "Most experts agree that climate change brought about by harmful greenhouse gas emissions and the warming of the Earth's atmosphere presents a major global threat with huge environmental, economic, and social implications. Climate change is a paramount challenge and the far-reaching and fundamental consequences for the economy, environment, public health, and safety are just now being fully understood. With the growing interest in climate change, there has been a heightened awareness of potential impacts of climate change on public health, particularly in disadvantaged communities." (PAS 586, p. 57)

To continue the mission of the Regional and Intergovernmental Planning Division (RIPD) to provide Division members and APA at large with best practices in regional and intergovernmental planning, the RIPD Executive Committee is exploring opportunities to more thoroughly examine emerging trends in regional climate change mitigation and adaptation planning highlighted in the PAS report. The Division's research will focus on water-related issues that are being impacted by climate change identified in APA's 2016 Water Policy Guide: water quantity and quality - human uses; water in the West; stormwater and flooding; water resources in the environment; and, integrated water resource management. APA's Water Policy Guide recognizes the importance of water as a central and essential organizing element in healthy environments along with the importance of planning to ensure that land use, environmental and infrastructure planning for water will increase resilience to extreme events and climate change. However, the Policy Guide also acknowledges that new mechanisms for interdisciplinary efforts are critical to effective water management and protection of the water environment. As noted in the PAS report, regional planning has further advanced integration of complex related issues and is especially relevant when a broad set of planning concerns require coordination at a scale not matching the jurisdictional boundaries of any existing general-purpose government (federal, state, county, or city levels). The RIPD Executive Committee therefore supports this effort to provide practical advice for practitioners working at various regional scales about this complex and critical issue.

To assist with our effort to conduct this research, we hope to engage with students and faculty at the University of Minnesota Humphrey School of Public Affairs through a project next Spring and we applied for a Divisions Council product grant to produce a Handbook for Division members. Future editions of the E-news will include periodic updates and information about how members can get involved in this important project.

Chair's Message:

In September, RIPD Chair Mark VanderSchaaf sent the following message to new student members of the Division. APA subsequently shared this message with all Divisions as a model for the to follow in engaging with new student members.

Dear APA Student Member:

Welcome to the Regional and Intergovernmental Planning Division. We are delighted to learn of your interest in our work as the division that focuses on ways in which federal, state and regional planning intersect with planning in local communities. We are proud of our division's work and its contributions to the planning profession. In particular, we bring to your attention our award-winning Planning Advisory Service report, "Emerging Trends in Regional Planning," released earlier this year and now available to you to download as an APA member. We have several opportunities to further your involvement in our division and its ongoing work:

- 1. We will be appointing a Student Representative to our Executive Committee, which meets monthly via a conference phone call and in-person at the APA annual conference. This will be a great opportunity to network with some of the best people in the profession and to assist with our leading-edge work. I am attaching an Executive Committee roster and an invitation for you to get in touch with any of us if you want to explore issues relating to our specific responsibilities. If you are interested in the Student Representative opportunity, please send me a brief description of your interest and a current resume by end of day, Monday. October 9.
- 2. Assistance with our current and new program areas. Currently we have a well-established annual Livable Communities Forum, in partnership with the Lincoln Institute of Land Policy, that brings together senior leaders from regional planning agencies and Metropolitan Planning Organizations across the country. This forum focuses on "best practices" to integrate innovative multimodal transportation projects with housing and other land uses in communities throughout the U.S. We are also developing programs to advance regional strategies for climate change mitigation and adaptation, and regional planning for arts and culture. We hope that the Student Representative may be able to help us implement on-line learning opportunities during the year to spotlight each of these programs.
- 3. Contributions to communications and membership recruitment. We have a quarterly enewsletter, and wish to enhance the use of webinars and social media to build the regional and intergovernmental planning community. We have a Twitter handle and encourage you to follow us there @APARegions. We are also interested in strengthening our connections with faculty and students in university regional planning programs throughout the country.

4. 2018 National Planning Conference, New Orleans, April 21-24. We will hold our annual meeting and Livable Communities Forum in conjunction with this conference, and hope to be involved in several conference presentations. So please consider attending and connecting with us there.

Spotlight on Regional Planning

The Chicago Metropolitan Agency for Planning (CMAP) is developing the region's next comprehensive plan, <u>ON TO 2050</u>, scheduled for adoption in October 2018. As with its predecessor <u>GO TO 2040</u>, this is a highly transparent and collaborative effort involving partners and stakeholders from across the seven counties and 284 communities of northeastern Illinois. CMAP's Board and stakeholders have asked that ON TO 2050 provide more specific direction to local communities to help them implement the plan.

From April through August 2017, residents weighed in on five Alternative Futures that could shape our region for decades to come:

- What if <u>climate change</u> impacts intensify by 2050?
- What if more people choose <u>walkable communities</u> by 2050?
- What if innovative transportation changes how we get around by 2050?
- What if a transformed economy can enhance prosperity by 2050?
- What if constrained resources challenge our communities and region by 2050?

During that engagement phase, CMAP connected with more than 2,500 residents who attended 127 workshops and five topical forums and over 61,000 who interacted with the kiosks. 55 of these workshops were structured for local government staff to offer feedback on how the plan could help them.

In October 2017, an ON TO 2050 Preview Report will describe broadly the strategic recommendations that the draft plan is likely to include when it is posted for public comment in June 2018. The preview is organized according to three overarching principles that support the regional vision and will be relevant across the ON TO 2050 plan's strategies: Resilience, Inclusive Growth, and Prioritized Investment.

Among the preview recommendations slated for inclusion in the regional plan is to "increase the capacity of communities to achieve local and regional goals." The importance of municipal governments in providing for a high quality of life cannot be overstated. While municipalities in the region largely wish to move local and regional goals forward, some face substantial barriers, such as a lack of technical knowledge by staff or elected officials, low staffing levels, poor fiscal condition, lack of political will, or constituent opposition to plans and projects. These barriers can limit municipalities' abilities to plan proactively and make them reactive to shocks and stresses rather than resilient. While the CMAP Local Technical Assistance (LTA) program has had success helping communities across the region, ON TO 2050 will identify even more ways to ensure that all municipalities function effectively and efficiently, have adequate staff and financial resources, and are able to define and fulfill long-term local and regional goals.

For example, CMAP should refine the LTA program's offerings to include related technical assistance and trainings and could also provide complementary guidance on such subjects, such as economic development, coordinated investment, plan implementation, or consolidation. ON TO 2050 will also propose strategies for municipalities to increase their capacity, such as partnering with adjacent or overlapping jurisdictions to share services or pursue joint purchasing, consolidating units of government or certain services to improve services or gain efficiencies, and implementing planning strategies to improve investment prioritization, such as capital improvement plans or more detailed and transparent budgeting.

Greening the Green Line

A new program area for our division is regional planning for arts and culture. At the upcoming national APA conference, I'll be moderating a session on this subject featuring innovative programs recently launched in the Boston, Chicago and Seattle areas.

My interest in the subject originated in my previous career as the regional planning director at the Metropolitan Council of the Minneapolis/Saint Paul area, where my job description increasingly involved helping to promote arts and cultural activities connected to the work of my agency. There I discovered that we were not alone, as regional planners throughout the country were also beginning to engage with the arts and culture, often within the context of public art projects connected with transit and transit-oriented development.

This process was assisted by national organizations documenting and promoting best practices in the field during the past decade – notably the American Public Transportation Association's "Best Practices for Integrating Art into Capital Projects" (https://www.apta.com/resources/standards/Documents/APTA-SUDS-UD-RP-007-13.pdf), Transportation for America's "Creative Placemaking" interactive website (http://creativeplacemaking.t4america.org/), and their collaborative project with ArtPlace America. "Arts. Culture and Transportation" (http://t4america.org/maps-

tools/creative-placemaking-field-scan/). APA has also been active in this field recently, partnering with the nonprofit Forecast Public Art to develop curricula for planners around public art and healthy communities, supported by National Endowment for the Arts 2016 "Our Town" grant (https://www.planning.org/blog/blogpost/9104791/). APA also received a 2017 "Our Town" grant to integrate the arts into planning processes throughout the country (https://www.planning.org/newsreleases/2017/jun15/).

A Model in Minneapolis/Saint Paul

As is true in many places now, the Minneapolis/Saint Paul area exhibits a public art paradox. At the same time that new federal criteria prohibit the funding of public art in rail transit stations, cities served by transit are embracing public art as vital to their transit-oriented development strategies and are finding creative ways to include public art in their strategy implementation. How did this happen? What does it portend for the future of the art/transit/transit-oriented development nexus?

The Minneapolis/Saint Paul area currently has two light rail transit lines. The "The "Blue Line," opened in 2004, connecting the Mall of America, the MSP International Airport, and downtown Minneapolis. Under old federal funding guidelines, this project invested substantially in public art at the station platforms, yielding a collection of 19 unique stations, each in effect a distinctive work of public art. But at that time, less attention was paid to public art in the adjacent neighborhoods in the cities of Bloomington and Minneapolis where the stations were built.

In 2014 the "Green Line" (located along the "Central Corridor") began service, connecting the downtowns of Minneapolis and Saint Paul. In contrast to the Blue Line, Green Line stations are substantially the same, with tasteful but subdued works of public art embedded in each station. But also in contrast to the Blue Line, residents along the Green Line early began desiring public art as a way to strengthen the identity and livability of their neighborhoods, to affirm their historic traditions and to solidify a neighborhood brand to help guide future development.

Unlike the government-funded public art of the Blue Line a decade earlier, neighborhood public art along the Green Line was supported by a variety of implementing partnerships, working to enhance each neighborhood while contributing to a "charm bracelet" that integrated thematically the entire Green Line corridor – a corridor consisting of a highly-diverse set of communities with rail service provided largely down the middle of a highway thoroughfare. Metropolitan Council, the regional planning agency, has filled several niches within these partnerships.

- Since 1995, the Metropolitan Council has awarded approximately \$15 million
 per year in "Livable Communities" grants to local governments to support
 walkable, mixed use neighborhood development. The eligibility criteria have
 evolved over the years, but by 2017, included funds specifically set aside for
 transit-oriented development, and eligible uses that include placemaking and
 public art.
- In 2011, Metropolitan Council co-sponsored a community workshop with the British cultural consultant Charles Landry, "Unleashing the Potential of the Central Corridor: Building a Great Street with Creativity, Distinction and Economic Prosperity." Landry's 2011 workshop was followed by a week-long residency in 2012, where Landry worked mainly with neighborhood leaders along the route of the Green Line within the theme of "Creating 21st Century Intercultural and Creative Cities."
- On the opening day of Green Line service in 2014, MetroTransit (a division of the Metropolitan Council) promoted art/culture-oriented festivals at nine different station area neighborhoods with the theme "Destination Anywhere: Where Will You Go First?," providing a set of collector-item buttons, one available at each of the nine stations. MetroTransit continues to promote the diverse set of Green Line neighborhoods with its "Explore the Twin Cities on the Green Line" poster, often featured at Green Line stations. This "destination anywhere" identity for the Green Line is becoming well-established throughout the region and its arts community; in 2017, the annual Northern Spark all-night arts festival selected the entire Green Line for its set of venues. With 415 artists, 45,000 attendees, and 33,000 LRT rides, the Green Line admirably fulfilled its role as a multi-site host for this festival.

Partnerships are Key

Not all of the implementing partnerships along the Green Line involve the Metropolitan Council directly. The complete universe of such partnerships is too vast to be encompassed by this article, but I highlight one example that is a special favorite of mine. "Greening the Green Line" is a vision promoted by the Minnesota chapter of the Trust for Public Land, which works with communities to advocate for, and lead efforts to create new parks.

Although public art and creative placemaking can occur in non-public spaces, these new parks will provide important venues for art and cultural projects. They can also extend the vision into fields beyond transit including, for example, new forms of water resource management that also provide amenities to the surrounding community. I'm already seeing interest in combining innovative stormwater management with public art and I expect it to grow in the years to come.

The Minneapolis/Saint Paul area is now on the verge of extending both the Blue Line and the Green Line into northern suburbs and southwestern suburbs respectively. In both cases, the example of the existing Green Line is being tapped to prepare proactively for transit-oriented development that will prominently feature public art, both as a way to enhance each community served by the new transit line, and as a way to strengthen a region-uniting identity for the new transit corridor.



Embracing Change Won't Be Easy For The New York Region

With a name like The Fourth Regional Plan, the 376-page document drafted for the tri-state region of New York, New Jersey and Connecticut might appear on its face as routine.

It does have the kinds of land use maps, traffic congestion models and job growth projections found in most every long-term regional plan, but scratch beneath the surface and it becomes clear the this plan by the Regional Planning Association is designed to make people, well, uncomfortable.

While calling the New York region a prosperous area loved by its residents, the RPA report states that congested roads, overpriced housing and the threat of sea level change will require drastic measures to plan for the near and distant future.

That means extensive tolling of roads and highways – including every road into Manhattan – installing a comprehensive cap-and-trade emissions program, and the future abandonment of major assets that will be swamped by climate change-induced sea level rise.

It's the first plan update since 1996.

"Our last plan had a single line generally saying 'keep an eye on climate change'," said Moses Gates, RPA Director of Community Planning & Design. "This one operates from the assumption that sea level rise will have a major impact on our future."

The Regional Planning Association is a respected, non-governmental planning organization that covers a tri-state region with 23 million residents and an economy that, at \$1.8 trillion, represents 10% of the nation's economy. And that economy is rolling right now, but that could change if the region doesn't begin making tough choices now, the report states. The Fourth Regional Plan includes more than 60 recommendations designed to be a roadmap to carry the region through 2040 and beyond. It's been criticized by some who have called it a scattershot approach of big ideas that can overshadow some of its smaller, more practical solutions, but Gates said the recommendations address issues in most every sector of the region and issues ranging from transportation congestion to social justice.

Because the RPA is not a municipal board, and serves entirely in an advisory capacity for the local governments it serves, the RPA's recommendations are not binding. And because it's not the Metropolitan Planning Organization for the region – other agencies manage and dole out the transportation money – it doesn't have the hammer of withholding funding to force municipalities to act.

But that kind of autonomy also gives it the freedom to be candid in its recommendations, Gates said, and that's reflected in a document that's been five years in the making. It advocates a change to a sort of user's fee society that would raise as much as \$5 billion a year for infrastructure improvements by charging motorists for entering Manhattan and tolling most major highways and another \$3 billion a year by installing a cap-and-trade program – modeled after California – that would reduce pollution by forcing industries and even motorists to buy carbon credits for their emissions.

Working on the assumption that the region will experience a six-foot sea level rise by the turn of the century, the plan suggests expanding JFK and Newark airports, in part, because it projects that the region's primary general aviation airfield – Teterboro Airport – will be swamped.

It also projects that sea rise will displace 4,000 to 8,000 residents and 51,000 jobs in the Meadowlands, so it recommends transitioning away from those homes and businesses and establishing a Meadowlands National Park.

Other recommendations include prioritizing people over cars on all urban streets by creating more space for pedestrians and bicyclists, removing highways that create blight, and building 300,000 accessory homes, particularly in areas around train and subway stations, to help address the affordable housing, equity and access problems. It also suggests a series of connections that would create a 1,650-mile tristate trail network.

The plan is packed with recommendations that can't be done easily, quickly or cheaply. And the ramifications of getting people to pay as they go could be dangerous for the leaders in the municipalities or agencies that choose to implement them.

But Gates notes that many of the recommendations of previous plans have been implemented, including some that seemed daunting at the time. For example, the 1996 plan suggested a connection from the Long Island Railroad into Grand Central Station, Gates said. The \$10 billion project, including several tunnels, is underway and scheduled to be completed in 2023.

The Fourth Regional Plan hit the streets Nov. 30.

"We put this out there to drive conversation and it's certainly done that " Gates said

"We've definitely gotten some pushback, but we've heard support too. It's going to take time and a lot of conversation."

Chair's Message: Join us in New Orleans!

Livable Communities Forum

You've received previous communications about RIPD's annual livable communities forum, a free day-long event held in conjunction with the National APA conference. This year the forum will be held on Friday, April 20th at the New Orleans Holiday Inn Superdome downtown. Since 2013, this annual event has brought together leading practitioners from around the nation to share best practices and promising strategies to ensure the collaborative implementation of regional plans. This year's forum will continue to spotlight planning and technical assistance programs administered by regional agencies to support local implementation of long-range transportation and growth plans. Given recent flooding and resiliency efforts underway in the Gulf Coast, this year's forum will also include discussion of regional efforts to address recovery and adaptation within regional plans, and emerging best practices by regional agencies to address new complex challenges. This includes how to revise capital budgeting and forecasting in times of fiscal uncertainty and demographic change, and how efforts by regional agencies to engage in housing issues, which typically are a local concern. In many instances, regional livability programs are part of the solution, but this year's forum also looks at how livability principles and integration of issues are being reflected in longrange planning and innovation solutions focused on local implementation. 

Chair's Message: Milestones and Transitions

NPC18 was a remarkable event in a remarkable city. New Orleans is always an exciting place to be, but it was a special thrill to have APA's national conference coincide with the city's 300^{th} birthday – a major milestone marking New Orleans' rich history and culture, but also a time of heightened reflections on the transitions that need to occur for the city to remain resilient in an age of sea level rise and increasingly extreme weather events.

For the Regional and Intergovernmental Planning Division (RIPD), NPC18 was also a time to reflect on milestones and transitions. Our Executive Committee has now served 75% of its two-year term, and NPC18 featured successful events for all three of our current programs areas: Livable Communities; Climate Change Adaptation via Integrated Water Management; and Regional Planning for Arts and Culture. We can all be proud of these milestones.

Transitions for RIPD are picking up steam and will accelerate through the end of 2018 and early 2019. I highlight three:

- 1. Officer Elections: RIPD members are now electing a new slate of officers for 2019-2020. We'll be seeing many new faces as a number of our current officers are stepping aside to create opportunities for new leadership in the division.
- 2. Biennial Survey: You will shortly receive a survey that will be used to help us evaluate RIPD's current activities and programs. It will especially assist our new Executive Committee as it guides the work of RIPD in 2019 and 2020
- 3. Criteria for Establishing RIPD Program Areas: With the success of our current model of operating through program areas, the Executive Committee created guidelines to follow as we consider adding or subtracting program areas in the future. Water Planning and Climate Change Project Update

As reported in a previous E-news, RIPD was awarded a product grant from the APA Divisions Council in 2018 to develop a policy handbook on integrated water resource management to address climate change at the regional scale. RIPD applied for the product grant in response to a 2016 APA Policy Guide on Water that recognized the importance of water as a central and essential organizing element in healthy environments along with the importance of planning to ensure that land use, environmental and infrastructure planning for water will increase resilience to extreme events and climate change. In addition, an extensive survey of APA members in 2017 identified climate change as the single most important issue to address in the foreseeable future, with "regional" as the most appropriate geographic scope to address that issue.

The RIPD policy handbook will synthesize ways in which state and regional activities in integrated water planning for climate change support coordinated local planning and implementation strategies in megaregional, metropolitan, micropolitan, and rural areas. In addition to examining regions at different scales, the handbook will feature case studies from around the U.S. representing diverse "ecoregions" from both a water resource and climate perspective.

RIPD distributed a survey in April to RIPD members and other stakeholders at various levels of government to assess the current level of coordination and integration in water resource and climate change planning. We received a total of 45 responses from 27 states covering most geographic regions of the U.S. Approximately 60% of respondents indicate some integration of water resource issues in regional water resource plans and integration of climate change issues to some degree.

APA RIPD has been reviewing studies and research papers to incorporate and/or reference in the policy handbook, including information on integrated water management or a "OneWater" approach; factors affecting water availability; and how water resources availability is exacerbated by climate change.

Based on our research and the results of the survey, RIPD has also identified several regions as promising case studies to highlight in the handbook and are engaging with student contributors and professionals in the planning, water and legal fields to develop the case studies. Earlier this year, graduate students from the University of Minnesota Humphrey School of Public Policy completed a case study on the Minneapolis – St. Paul region that will be featured in the handbook.

RIPD will be presenting an overview of the upcoming handbook and highlighting some of the case studies at the APA Water and Planning Connect conference in Kansas City, MO on September 11-12, 2018. 

Q1 Which state(s) do you work in? Please list all that apply.




Q3 Please indicate the type of practice you are employed in. Please check all that apply.


Q4 What is the major focus of your work? Please check all that apply.



Q6 Does your state have a water resources management plan?




Q8 If "Yes" to Question 6, which of the following issues are integrated into the statewide water resources plan? Please check all that apply.



Q10 Which agency(ies) have regulatory authority over water resources in your state? Please check all that apply.



Q11 Is there a central authority over water resources in your state?






Q14 If "Yes" to Question 13, which of the following issues are integrated/addressed within your regional water resource plan? Please check all that apply.



Q15 To what degree are regional/local water plans coordinated/integrated in your state?








Q1 What are the most pressing issues facing your region? Please check all that apply.





Q3 What federal legislative initiatives would most benefit your region? Please check all that apply.





Q4 How often have you read the Division E-news in the last year?









Q7 Are you or your organization interested in contributing content to the Division E-news?



















Q23 What is your American Planning Association Membership Type?







Chair's Report

Mark reported that the Division now has about a thousand members, up from less than 300 last year. This is largely a result of nearly 700 student members joining under the new APA policy allowing college and university students to join APA and its divisions for free. He asked that the Division think about was to increase student involvement.

Mark also reported that the division adopted new bylaws last year to better support its mission and vision.

Mark stated that the Divisions Emerging Trends report won a chapter award last year, and that the Division should make an effort to stay current with emerging trends.

Secretary-Treasurer's Report

Lamont reported that he would share the approved Work Plan with Division members.

Livable Communities

Mariia reported on a few new ideas for the future Livable Communities Forum. She suggested targeting all the MPOs to provide a benefits letter or e-mail to raise money, charging a nominal fee for folks to attend the forum.

She also mentioned there was a big increase in attendance after the Lincoln Institute invited folks to attend the forum.

Attendees asked if the Division had approached Association of Metropolitan Planning Organizations (AMPO) and National Association of Regional Councils (NARC) about supporting Livable Communities. Mariia stated there was limited support from NARC but she asked them to promote and circulate the information. The National Association of Development Organizations (NADO) shared the information, but NARC and AMPO did not.

Another idea was shared to host peer events with partner organizations during the year, and coordinate events with partners so that the same funds are used to achieve the same goals.

Assuming that the attendance is the same, the Metropolitan Transit Commission in the Bay Area would be able to host next year. Attendance will depend on the topic. The topic should be compelling and interesting enough to attendees. The agenda should not change the approach to the new forum, but the agenda for next year should be topical to the west coast.

Mariia reported that this year's forum was more of a sampler, and also included a webinar that was well attended, with SCAG helping to host. The Division is certified to provide CM credits through future programs.

Mariia reported on initial feedback from this year's forum. Forum attendees reported that they like the three-slide format of presentations, and panelists sitting on barstools. Attendees from regions with stagnant growth felt ignored, and there was interet in doing a webinar for slower-growing areas in the summer to connect with them and offer AICP credits.

Mariia also stated she would not return to lead the forum next year.

Mariia stated that last year, she shared summaries of the various livable communities programs on a mini website. This year, she recommended the information be placed on the division websites.

Communications Report

Becky reported that the division must work closely with APA to get them to put things on the new website, the resources link on the "APA ENGAGE" site.

Meeting attendees mentioned that in the past, the division had a detailed journal, and released a newsletter four times last year. After testing long and short versions of the newsletter, Becky plans to do a midlength newsletter with original content, including subtopics under regional planning. The division's Twitter and Linkedin pages are set up, but the division needs a long-term strategy to update these pages.

Meeting attendees agreed that the division should start a member director, and focus on getting information and contacts from FHWA or AMPO. The forum attendees should also be the first names in the directory.

Becky is preparing the second version of a member survey for release.

Student Representative's Report

Mark gave the report, in lieu of Kyle Smith. Mark stated the division reached out to student members to increase their involvement. Eight students signed up, and Kyle Smith was selected to be the student representative.

Mark recommends reaching out to local programs and wants the division to collect more information from students on their schools and regions. He will verify from Kyle if the student survey went out.

Meeting attendees noted that it should create better linkage between division and student community, especially since many students don't know about regional planning. With 700 student members, the division has to show its value to them. The division should connect them to jobs and get members to post job information. It was also suggested that the division reach out to PhD students.

Meeting attendees also suggested better connecting the work plan and budget to programming for students.

Climate Change and Water Management

Sharon stated the grant for the project was signed and she did a short presentation at the conference. She is working with University of Minnesota students as part of their capstone program to come up with a framework for other regions to use. The project outcomes include a policy handbook for division members. Sharon also said she is working with Becky and student member John MacDougal to market the survey related to the project.

Sharon mentioned that she is working with the Lincoln Institute and the Babbitt center for a case study on the Colorado River. She will also attend the water and planning connect conference.

Meeting attendees recommended sharing the project with the Institute for Sustainable Communities in Vermont, and to reach out to other divisions with related interests.

Regional Planning for Arts and Culture

Mark noted his upcoming panel and said this topic area is an emerging trend in regional planning. He noted that a new APA division around arts and culture being developed (currently the Arts and Planning Interest Group) and growing a network of planners who emphasize arts and culture.

New Business and Open Discussion

Meeting attendees discuss the division's criteria for new programs and suggested the division integrate new programs with APA's broader mission, focus on emerging trends and the future, and allow anyone from the division to encourage new programs, not just the executive committee.

Carolyn recommended a possible project around regional housing affordability and housing markets. This is a pressing regional issue, and the division could look at other regional assessments of fair housing and connect with other local planners on these issues.

Sharon mentioned the member survey could be shortened, but is ready to be released by June at the latest. Meeting attendees recommended culling questions about activities, looking to Peter Conrad's survey as a template, and discussing national level issues. Attendees also recommended being more specific and putting more interesting questions upfront in the survey. Some questions could be tailored more toward students than working professionals.

Mark noted that May 15 is the deadline for APA members to self-nominate for offices in fall division elections. The division needs elected officers for Chair, First Vice-Chair, Federal Planning, State Planning, Metropolitan and Regional Planning, and Secretary-Treasurer, . The group also needs to confirm who is and is not planning to run.

Appendix I RIPD Bylaws

Appendix i. RIPD Bylaws

Regional and Intergovernmental Planning Division Bylaws last amended May 7, 2017

1.0 General

1.1 Name

The name is the Regional and Intergovernmental Planning Division (hereafter the Division) of the American Planning Association (hereafter APA or the Association).

The Division has been authorized by and is subject to the Bylaws of the APA.

1.2 Purpose

The Division shall foster an interest in, contribute knowledge to, and promote cooperation for regional and intergovernmental planning and implementation by:

- 1.2.1 Creating a network of planners to contribute to the promotion of interests, concerns, practitioner skills, and the competence of its members in a common area of interest or identity, where learning, research, advocacy and interaction serve to advance the security of planners and the role of planning in building communities.
- **1.2.2** Disseminating materials and information about current regional and intergovernmental planning and implementation practice and theory to members of the Division;
- 1.2.3 Assisting and educating the Association about pending legislation; planning policy; and membership welfare, which may include but is not limited to workplace fairness, equitable programs and benefits, and opposing discrimination that affects regional and intergovernmental planning and implementation;
- **1.2.4** Facilitating connections with Divisions, Chapters, and other professionals and professional organizations that are concerned with regional and intergovernmental planning and implementation; and
- **1.2.5** Promoting professional communication among members of the Division through a variety of member services, including but not limited to periodic newsletters, conference sessions, workshops, webinars and other publications.

1.3 Mission

The mission of the Division is: to identify, analyze, and promote best practices to strengthen the productive interdependence of local, regional, state and federal government in the planning and development of our nation's communities. It especially emphasizes the way in which state and regional activities support the coordination of local plans and implementation strategies in megaregional, metropolitan, micropolitan, and rural areas.

1.4 Nonprofit status

Divisions are recognized as subordinate entities under the nonprofit 501(c)(3) status of the American Planning Association.

1.5 Procedures

- **1.5.1** Procedures shall be informal for meetings with fewer than 12 people.
- **1.5.2** For meetings with 12 or more people, procedure shall be governed by basic parliamentary procedures as a guide (or Robert's Rules of Order).
- **1.5.3** It is encouraged, that wherever reasonably possible, decisions shall be reached by consensus.

2.0 Membership

2.1 Eligibility

Any Association member may join upon payment of the Division's dues. All Division members must belong to the Association.

- **2.2** Non-Association members may become Division Affiliates upon payment of Division Affiliate dues.
- **2.3** Division-only affiliates shall not represent themselves as members of the Association.

2.4 Termination

Division membership or affiliation will be terminated upon failure to pay Division dues.

3.0 Decision-making

- 3.1 The Executive Committee shall make decisions by majority vote so long as a quorum exists, except where specified otherwise in these bylaws.
- 3.2 The Executive Committee shall determine the means of disseminating information about decisions requiring a vote by Division membership to ensure accessibility.

4.0 Officers and Elections

The Officers are Chair, Vice-Chair, the Secretary-Treasurer, and the Immediate Past Chair, and others as required. Elected Officers shall include at least the Chair, Vice Chair and the Secretary-Treasurer. A Student Representative or other leadership team members may be appointed or elected at the discretion of the Officers.

4.1 Elections

4.1.1 Elections will be held every two years in the fall of an even-numbered year. Newly elected officers will assume office on January 1 of the following odd-numbered year.

- **4.1.2** No Division member may serve more than two consecutive terms as Chair of any single Division.
- **4.1.3** No Officer shall serve more than two consecutive terms in the same position.
- **4.1.4** The Division Chair may serve up to two terms, consecutively or non-consecutively.
- **4.1.5** The Division Chair will appoint a Nominating Committee consisting of at least three Division members to issue a call for nominations from the Division membership and conduct an election. Nominating Committee members may not include members running for office.
- **4.1.6** The Nominating Committee will present an election schedule which includes a call for nominations, submission of candidate material, and balloting window for the Executive Committee's approval.
- **4.1.7** The Nominating Committee shall allow at least two weeks for nominations to be submitted.
- **4.1.8** A Division Affiliate member is permitted by the Bylaws of the Division to hold an elected office other than Chair or Chair-Elect.
- **4.1.9** Election results are based on a plurality of the valid ballots received.
- **4.1.10**In the case of a tie, the Nominating Committee Chair shall determine the winner by random drawing.

4.2 Chair

The Chair shall:

- **4.2.1** Act as the presiding Officer of the Division;
- **4.2.2** Preside over all Division meetings;
- **4.2.3** Prepare or oversee preparation of an Annual Performance Plan, Work Plan, and Budget for approval by the Executive Committee;
- **4.2.4** Serve on the Divisions Council of the Association;
- **4.2.5** Appoint committees and others necessary to carry out the annual work program;
- **4.2.6** Make other delegations and decisions necessary to carry out the Mission and Purpose of the Division;
- **4.2.7** Be responsible for Division compliance with requirements in the APA corporate by-laws, current Division Performance Criteria and Division Council Policies and Procedures.

4.3 Vice-Chair[s]

The Vice-Chair[s] shall:

- **4.3.1** Assist the Chair as directed including, but not limited to, manage committee activities, assist with special projects, assist with the creation of the Annual Performance Plan and Work Plan and planning efforts associated with the annual business meeting or the APA Annual Conference;
- **4.3.2** In the absence or resignation of the Chair, the Vice-Chair shall assume the duties of the Chair, and other duties as assigned by the Chair. The Vice Chair shall assume the duties of Chair until the term of the vacated Chair is complete, whereupon the Chair-Elect will complete his or her elected leadership term.

4.4 Secretary-Treasurer

The Secretary-Treasurer shall:

- **4.4.1** Prepare minutes of the Division's annual business meeting and all Executive Committee meetings;
- **4.4.2** Submit proposed Bylaw amendments to the membership;
- **4.4.3** Fulfill all recordkeeping and reporting requirements as stipulated by APA National:
- **4.4.4** Be responsible for on-going communication to members;
- **4.4.5** Manage Division funds in accordance with the Division budget;
- **4.4.6** Assist the Chair in preparing the Budget to be approved by the Executive Committee and submitted with the Annual Performance Plan and Work Plan;
- **4.4.7** Prepare an annual financial report to be presented to the Executive Committee as well as the Division's members at the annual meeting

4.5 Immediate Past Chair

The Immediate Past Chair succeeds to this position upon completion of his/her final two-year term as Chair and may serve in this position during one or both terms of the Chair. The Immediate Past Chair shall undertake such duties as may be assigned by the Chair and will be available for guidance to the Chair-Elect during the transition period.

4.6 Student Representative

The Student Representative may be appointed by the Chair after consultation with the Officers and shall:

- **4.6.1** Serve as a liaison between the division's student members and executive committee;
- **4.6.2** Lead efforts to recruit student members to join the division;

- **4.6.3** Represent the division in activities and committees where student representation is needed;
- **4.6.4** Promote student involvement and engagement in the division

4.7 Vacancies

- **4.7.1** In the absence or resignation of the Chair, the Vice-Chair shall assume the duties of the Chair, and other duties as assigned by the Chair. The Vice Chair shall assume the duties of Chair until the term of the vacated Chair is complete, whereupon the Chair-Elect will complete his or her elected leadership term.
- **4.7.2** All other vacancies will be filled for the unexpired term by: a vote of the Executive Committee within three months.

4.8 Termination of Division Officers

In the event that a Division officer is unable to perform his/her duties and/or is not functioning within the guidelines their elected position outlined by the APA and Division Bylaws and the Division Performance Criteria and Policies, the subject Division officer may be asked to resign or be terminated from his/her position by the majority vote of the Executive Committee.

5.0 Executive Committee

5.1 Composition

The Officers, as defined in Section 4.0, and additional leadership team members elected or appointed at the discretion of the Officers, shall comprise the Executive Committee. The Officers, as defined in Section 4.0, and additional leadership team members elected or appointed at the discretion of the Officers, shall comprise the Executive Committee. Additional members may be added as necessary to facilitate division administration and programs by a majority decision of the Officers of the Division.

5.2 Duties of the Executive Committee

- **5.2.1** Manage the affairs for the Division.
- **5.2.2** Prepare and approve the annual performance plan, work plan and budget, using templates specified by the Divisions Council Executive Committee.
- **5.2.3** Authorize expenditures consistent with the budget and subject to consent by the Chair.
- **5.2.4** Administer the division's by-right educational session at the National Planning Conference, and other sessions as warranted.
- **5.2.5** Consult, electronically or in person, to coordinate the activities of the Division as needed.

5.3 Meetings

- **5.3.1** Meetings of the Executive Committee, be they through a traditional meeting gathering, a teleconference, or some other type of electronic communications, shall be called by the Chair, or by a majority of the Committee members.
- **5.3.2** A majority of Executive Committee shall constitute a quorum or by a majority of all Executive Committee members if the decision is not made in a meeting (e.g. via email).

6.0 Committees

The Executive Committee may form (and dissolve) committees, drawn from Division membership to carry out the activities of the Division. The Chair shall appoint a Committee Chair or Co-Chairs for each Committee. Committee Chairs or Co-Chairs may or may not be Division Officers. At the discretion of the Executive Committee, Committee Chairs or Co-Chairs who are not Division officers may serve as advisory members of the Executive Committee. Committee Chairs or Co-Chairs may be appointed to or removed from said position at the discretion of the Division Chair.

7.0 Finances

7.1 Dues

Dues shall be consistent with the APA division dues schedule for all categories. Dues are collected by national APA and are rebated by the Association's national office.

7.2 Non-Dues Receipts

Subject to approval by the Executive Committee, the Division may accept contributions, donations, and grants. The Executive Committee may establish fees for publications and services to be offered to non-members, or as special services to members, as long as these fees are consistent with charges determined by the APA Board.

7.3 Contracts

The Division shall not enter into contracts or obligate the Division financially or in name if said obligation or contract exceeds \$500 and is not described and proposed in an approved annual work plan and Division budget. All agreements, partnerships with outside organizations or individuals, or previously unidentified expenses shall be submitted to APA prior to any action being taken.

8.0 Publications, Media, and Branding

8.1 Identification

The Division shall utilize developed APA branding, logos, and imagery for all publications and media produced by or for the Division. Division publications

shall be identified with the full name, as, "a Division of the American Planning Association;" and with the uniform logotype of the Association.

8.2 Newsletter and other Member Communications

- **8.2.1** The Division is required to produce and disseminate regularly-scheduled communications to Division members in conformance with Divisions performance criteria. The purpose of these communications is to provide a benefit to Division members including opportunities to contribute articles and other content, stay current on Division or generalized planning industry news, and share information with other Division members.
- 8.2.2 Newsletters and other communications may be distributed in digital format or in hard copy via United States mail at the discretion of the Division.
- **8.2.3** A digital file of each newsletter shall be filed with National APA and posted on the Division's website.

8.3 Division Website

- **8.3.1** If the Division uses the APA Division website, the Division shall work with APA to ensure regular and current content is included on the Division's APA website.
- **8.3.2** For all division websites, quarterly website updates are recommended.

8.4 Other media communications

8.4.1 The Division may also maintain a presence through social media, ebulletins, or other communications as supported by APA.

9.0 Meetings

- **9.1** The Division shall hold an annual meeting during the APA National Conference. Notice of the annual meeting shall be distributed to Division membership via regular mail and/or email to the Division membership at least 30 calendar days prior the meeting.
- **9.2** Meetings of the Executive Committee shall be held monthly via teleconference.
- 9.3 Special meetings of members may be held at such times and places as may be ordered by: the Chair; or in the case of the Chairperson's absence, death or disability, the Vice Chair (or Chair Elect); or, a majority of the Executive Committee; or, by petition of 10 percent of Division members.
- **9.4** For special meetings, a written notice shall be delivered via regular mail and/or email to the Division membership at least 14 calendar days prior to the meeting.

10.0 Event Attendance and Travel Reimbursement Policy

- **10.1** The Division Chair, or designated proxy, shall attend the annual meeting at the National Planning Conference held in the spring. All other Division Officers are encouraged to attend the annual meeting.
- **10.2** The Division Chair, or designated proxy, must attend APA Leadership Meetings held in the fall.
- 10.3 Reimbursement of travel and lodging for all required Division officer activities shall be identified in the Division Work Plan and Budget as approved by APA. Levels of reimbursement shall be in stated the Division's budget, as determined by the Division Chair and Treasurer in conformance with Divisions Council Travel Policy.

11.0 Public Policy

No member shall represent the Division on Division policy without obtaining the approval of the Executive Committee. No member shall represent APA without obtaining the approval of the Executive Committee as well as the APA Executive Director.

12.0 Right to Privacy

All Division member anonymity shall be respected with regards to billing and other Division activities. Division members will be provided the opportunity to opt out of inclusion in division membership directories.

13.0 Amendments or Replacement

Any Division shall be free to amend or replace its bylaws at any time using the following procedure:

- **13.1** Proposed amendments or replacement bylaws may be proposed by either the Executive Committee or by a petition signed by at least ten Division members.
- 13.2 A copy of proposed bylaws or amendments shall be filed with the Association's National Office for review before distribution to members for adoption. If no response is received by the Association within 14 days of service, the Division may proceed with its adoption of the proposed amendments or replacement bylaws as drafted.
- **13.3** The Secretary shall submit the proposed amendments or replacement bylaws to the membership for their consideration.
- **13.4** Bylaws may be amended by a plurality of the valid ballots received. Mail or electronic ballots may be used.
- **13.5** Once approved, the current bylaws shall be filed with the Association.

Criteria for Establishing RIPD Program Areas

Presented at RIPD Annual Meeting April 22, 2018

Background

In 2018, APA's Regional and Intergovernmental Planning Division (RIPD) organized around three program areas: (1) Livable Communities; (2) Climate Change Adaptation via Integrated Water Management; and (3) Regional Planning for Arts and Culture.

With other ideas for program areas likely emerging from RIPD members in the months and years to come, it will be valuable for the Executive Committee to have criteria for determining how a program area gets established, and what are the benefits of being an RIPD program area. The Executive Committee will rely on these criteria to shape RIPD's annual work program and budget.

Criteria

- Must advance emerging trends and promising practices in regional planning and implementation strategies
- Must fall clearly within RIPD's mission and vision
- Must identify a lead from RIPD and involve at least two additional RIPD members
- The lead must be willing to participate in RIPD Executive Committee meetings as needed
- Should integrate productively with broader APA priorities and/or the work of other APA divisions or interest groups

Benefits

- Eligible for inclusion in the RIPD work program and budget
- Access to RIPD roster
- Use of RIPD communications and educational media (webinars, website, newsletter, social media, etc.)
- Collaboration with RIPD Executive Committee on development and endorsement of NPC sessions
- Networking with other RIPD members to leverage leadership and research opportunities
